

2019 Thai University Students to Exchange to Taiwanese Universities Scholarship Application

I. Sponsor: Thailand “Friends of Taiwan” Charity Foundation (泰國台灣之友慈善基金會).

II. Purpose

This scholarship was donated by Taiwanese businesspeople and overseas compatriot businesspeople. It is in order to encourage Thai university students to exchange to Taiwanese universities for experiencing Taiwan’s higher education.

III. Eligibility

The scholarship will be awarded to Thai university students who have succeeded in applying to, and will surely, exchange to Taiwanese universities in the next coming year.

IV. Scholarship Award

Each is awarded 60,000 baht to subsidize their expense to exchange to Taiwanese universities for at least three months.

V. Required Documents: **Thai students shall apply for exchanging to Taiwanese universities by themselves.**

- (1) Thai ID or passport copy.
- (2) Submit “2019 APPLICATION FORM OF SCHOLARSHIPS FOR THAI STUDENTS TO EXCHANGE TO THE TAIWANESE UNIVERSITIES” form (in English).
- (3) Acceptance letter as an exchange student of the Taiwanese university.
- (4) University transcripts (in English).
- (5) Letters of recommendation from university professors (in English).

VI. Application Date and Methods

- (1) Applicants shall send the required documents to Taipei Economic and Cultural Office in Thailand before 10 November 2019 for preliminary reviewing.

Thailand “Friends of Taiwan” Charity Foundation (泰國台灣之友慈善基金會) will announce the final results in December 2019. The scholarship winners must actually go to exchange to Taiwanese universities by 30 June 2020, otherwise they will be disqualified and shall return the scholarships.

VII. Scholarship Awarding Process

- (1) After the winner students have received Taiwan's visas to go to Taiwan, Thailand "Friends of Taiwan" Charity Foundation (泰國台灣之友慈善基金會) will award the scholarships and certificates of award to the students before the end of January 2020.
- (2) The winner students shall inform Thailand "Friends of Taiwan" Charity Foundation (泰國台灣之友慈善基金會) their account information. The Foundation will remit the amounts of the scholarship to the bank accounts designated by the winner students.
- (3) If the winner students eventually fail to exchange to Taiwanese universities, they must return the amounts of the scholarship to Thailand "Friends of Taiwan" Charity Foundation (泰國台灣之友慈善基金會).

VIII. Special Terms:

- (1) This scholarship is donated by Taiwanese businesspeople and overseas compatriot businesspeople, and will be given priority to the children of the donors' company staff who will exchange to Taiwanese universities.
- (2) Any scholarship recipient who submits any application document or any document when they are enrolling that is found to be fake, misleading, has been altered in some way, or contains any falsehood will have their scholarship revoked and must pay back all the scholarship.
